

The PASSWORD will be issued only to the bidders who comply with the Essential Eligibility Criteria (EEC) of the tender.

Introduction

Phase shifter, Stub, Gas barrier, switch & directional coupler are components of Mis-Match Transmission Line (MMTL) components assembly. All the above components contain coaxial cylinders/conductors with proper sliding arrangement. Sliding co-axial cylinders or plunger will be moved by servo/ stepper electric motor & driver. During operational phase, the coaxial cylinders will be heated up and so, the cooling arrangement is made to prevent overheating of cylinders. The co-axial cylinders will be cooled by compressed air at approximately 2 bar inlet pressure and cooling water at approximately 3 bar inlet pressure. The arrangements of cylinders are shown in below figures.





1 Essential Eligibility Criteria

Bids meeting the Essential Eligibility Criteria (EEC) shall only be considered as “Eligible Bids” and will be issued password for Technical part of Tender Documents including drawings. Bidder as mentioned in the EEC Table 1 means single Indian company/Indian industry. Bidder must submit two sets of self-attested copies of documents in support of eligibility criteria. However meeting the essential eligibility criteria in itself does not automatically qualify through the technical bid evaluation process.

2.4 Tender Documents / Tender Specifications & Requirements

The scope of work, scope of supply, technical specifications, engineering drawings, contract terms and bidding procedures are prescribed in the tender documents. The tender documents include the following Parts. Each Part is provided in a separate document with appropriate title.

2.5 Procedure for obtaining Tender Documents

a.	Tender Documents are available on ITER-India web site https://www.iter-india.org/tenders under “Opportunities for Industry/ITER India Tenders” menu select Public/Global Tender option for download except Part-A(II) .
b.	Bidders need to submit evidence/documents as per Section 1 EEC along with a Self-Declaration as per Annexure-A6/section:4.6) to the Purchase Officer, ITER-India on or before 15th May, 2020 by 1:00 p.m. at the address mentioned in clause No. 2.10.1(b).



c.	<p>Tender document i.e. Part-A (II) along with its Annexures & Drawings is protected with the PASSWORD. The PASSWORD to open/access the tender documents will be issued only to the bidders fulfilling the Essential Eligibility Criteria as specified in Section-1.</p> <p>Note: The password protected tender document i.e. Part-A (II) will be uploaded on website after completing the evaluation of EEC by Purchaser.</p>

2.7 Amendments to tender documents

- a. The Purchaser reserves the right to issue any amendments, clarifications, etc. to the tender documents, giving reasonable time, and prior to the bid opening. Such amendments, clarifications etc., to be taken into account by the bidders while submitting the bids and invariably enclose such documents as a part of the bid. All such amendments, clarifications, etc., shall be uploaded to ITER-India website and also notified through e-mail to potential bidders. The Purchaser will bear no responsibility or liability arising out of non-receipt of the same in time or otherwise.

2.8 Tender Fee & EMD

h.	EMD of unsuccessful bidder will be returned, without any interest, after the award of Contract (s).
i.	The EMD shall be forfeited if the bidder withdraws or amends or impairs or derogates from the submitted tender in any respect within the period of its validity
j. 2.9 Preparation of Techno-commercial Bids & Bid Content	
2.9.1 General	
a.	Before preparing the techno-commercial bids, the Bidders shall read all the tender documents carefully. Bidder who has submitted the bid against this tender shall be deemed to have read and understood the tender in totality.
b.	Detailed instructions and format for preparing the tender response and its content is provided at Section: 2 of this document. Different templates and formats have been provided to assist the bidders.
c.	The bids shall be prepared in duplicate. Each shall be clearly marked as “Original” or “Duplicate” . In the event of any discrepancy between them, the original shall prevail.
d.	The bid documents shall be prepared in English language only.
e.	All pages of the bid documents shall be numbered. Each page of the bid document shall be stamped and initialized.



- f. If the name of selected bidder is required to be changed for any legal reason, prior to entering into purchase order/ contract, ITER-India may permit the same subject to the condition that the bid remains the same in every respect except for the change of the name and relevant documents in this regard are submitted to ITER-India by the bidder immediately.

2.9.2 Techno-commercial Bid Preparation

- a. Bidders shall furnish all necessary details against Tender specifications provided in the Tender documents.
- b. Additionally **a soft copy of the documents for compliance to EEC, PART-A bid submission content** should be prepared in the form of **CD/DVD/USB Flash Drive** for submission. **Part-B (Price Bid) content shall be strictly avoided in this soft copy submission of the bids.**

2.9.3 Price Bids Preparation

- a. Refer to Price bid document (Part-B) for specific instructions and bid format on Price Bid preparation
- b. Bid should be free from Corrections and Erasures. Corrections, if any, must be attested. All total amounts shall be indicated both in words as well as in figures. Where there is difference between amounts quoted in words and figures, amount quoted in words shall prevail.
- c. Refer to Part-A (III) for Terms and Conditions of the Contract including the payment terms and submission of Bank Guarantees (BGs)

2.10 Bid Submission

- a. Bidder shall submit complete Tender document (single copy) duly stamped and signed by their competent authority. This will be considered as compliance to the tender document.
- b. Refer to Section-3 of this document, for more details on bid submission envelopes, their format and their content.
- c. All bids in response to this tender shall be submitted in **TWO PART** (Part-A & Part-B) in separate envelopes, duly sealed and superscripted with **Tender Notice Number, Due Date and Time** as per the details provided in Section-3 of this document. - d. All technical specifications and technical details along with commercial terms and conditions (**without price**) shall be included only in Part-A of the bid. **Part-B (Price bid)** comprising of price details shall be submitted in a separate envelope **only in Hard copy**.
- e. The bidder shall take special care in order not to mix-up price details with the Part-A (Technical and Commercial bid without price) and vice versa. Any violation of these conditions may lead to rejection of the bid.



- f. The Main envelope containing Part-A & Part-B bids shall also contain the **EMD** enclosed in a separate envelope (refer to section-3 for details). Proof of payment of Tender fee to be submitted along with EEC documents in envelope-1.
- g. The bidders are advised to use high quality plastic envelopes/covers to protect the bids from any damage in transit.

2.10.2 Due date for bid submission

- a. The completed bid documents in the prescribed format should be submitted to the Purchase Officer, ITER-India **latest by 13:00 hrs. (IST) on 15th July 2020.**
- b. In the event of any date indicated above is a declared Holiday, the next working day shall become operative for the respective purpose mentioned herein.
- c. Bidders are requested to prepare and submit their bids well in advance to the due date with due consideration of lead times required for an assured delivery by postal services to avoid unfortunate delays.
- d. ITER-India will not be responsible for any delay or loss of bid documents in transit.

2.11 Rejection of Late/Delayed Bids



a. Bids received after the due date and specified time will be declared as “**DELAYED**”. Bids received after the opening of bids will be declared as “**LATE**”. **DELAYED and LATE bids WILL NOT be considered** and therefore, it is in the interest of the bidders to ensure that the tenders reach the Purchase Officer, ITER-India on or before the stipulated due date and time .

b. The bids shall be valid at least for **120 days** from the date of opening of Part-A bids. In case of unforeseen delays in concluding the tender evaluation, ITER-India may request the bidders for a suitable extension of validity of their bids without any change in quoted price and terms & conditions.

2.12 Bid opening of Part-A

a. Bids will be opened in three stages (Stage-1: Part-A(I), Stage-2: Part-A(II) & Part-A(III) and Stage-3: Part-B at ITER-India office as indicated in this tender document.

b. At the first stage Part-A(I) Essential Eligibility Criteria will be opened next day after the deadline of submission of EEC documents in hard copies and soft copy. **Bidders need not attend the opening of Part-A(I).**

c. At second stage Part-A(II) & Part-A(III) Technical and Commercial bid without price will be opened in the presence of attending bidders or their authorized representatives.
