Technical Specification for Supply and Installation of Earthing Pit - Chemical Pipe in Pipe type

- 1. Introduction: This work need to be executed at DNB Lab, ITER-India Laboratory Building, IPR, Bhat Gandhinagar. The bidder may visit the site before submitting their bid.
- 2. Site Location: DNB Lab, ITER-India Lab. Building, Institute for Plasma Research, Bhat, Gandhinagar

3. Scope of Work:

The scope of the work includes following,

Installation & Testing of one maintenance free chemical type earthing electrode pit (Copper Pipe in Pipe Type Electrode) as per specifications mentioned in Sr.6.

A. Supply of chemical earthing electrode, Soil resistivity decrease compound, Earth pit lid and supporting accessories (e.g. Wire, Nut-bolt, Connectors-clamp etc.) and other required items for successful installation of one earthing pit

All material shall meet applicable IS Standard and Specification

- B. Preparation/Installation of Chemical type earth electrode, openable earthing pit chamber and associated earth/civil works/electrical work/painting- nomenclature work for estimated job
- C. Openable earthing pit chamber/enclosure shall meet applicable standard and quality e.g. (Outdoor use, UV resistant, corrosion resistant, durability, adequate space inside of chamber for easy connection with earth electrode, factory built holes for accessing strips/ wires easily etc.)
- D. 300 Sq. mm cross section (Copper) bus bar needed to be taken out side of earth pit with proper laying, fixing and covering for connecting earthing with system as required by ITER-India.
- E. Joint between Bus bar and Earth electrode should overlap and tighten properly and all joints should be protected by a heavy coat of bitumen.
- F. Measurement of earth resistance of earth pit with calibrated earth tester. (Proper testing equipment, tools to be arranged by vendor for testing)
- G. Before work commencement required drawing (with specification, dimension, layout etc.), test report related to earth electrode, soil resistivity decrease compound, etc if applicable. shall be submitted to ITER-India for prior approval. In case of any modification, clarification, holding points, and doubts, prior approval of ITER-India is required.
- H. Any other material/service required of successful completion of work.
- I. Civil Work:
 - a. For installation of earthing electrode civil work (excavation) will be done in such way that it should not affect surrounding area (excavation by proper boring tools/machine) and after installation site need to be restored as it was. (E.g. Removed paver block need to reinstalled/arranged properly in nearby space, cementing work where ever required, Cleaning etc.)
 - b. The tentative location/site of the earthing pits is shown in Annexure-1.
- J. Tentative schematic of earthing pit for understanding only refer Annexure-3

4. Applicable Standards:

Earthing system shall follow commissioning and testing as per IS 3043 guidelines.

5. Measurement of earth resistance:

The resistance of individual earth pits and complete earth system shall be measured as per IS 3043 and it shall be ≤ 1 ohm (with tolerance of 10% on higher side) approximate.


10. Termination for Default:


