If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. bid in respect of the offered service. ### **2. Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### **3. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
