Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods
- Actual delivery (and Installation & Commissioning (if covered in scope of supply)) is to be done at following address ITER-India, IPR Block-A Sangath SKYZ, Bhat-Motera Road, Koteshwar, Ahmedabad - 380005 Gujarat, India
- 4. **Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid
- 5. Buyer Added text based ATC clauses
 - 1. Bidder are requested to fill Bidder's compliance column (duly signed and stamped) of Tech nical Specifications as per Annexure-A attached in buyer added bid specific ATC. Bidder needs to sign & stamp on each & every page of attached Annexure-A. This will be considered as an acceptance of bidder on Annexure-A.
 - 2. Annexure-I attached in Buyer Added bid specific ATC Document: Self-declaration by Bidder for compliance as per Rule 144(xi) of GFR 2017. This Annexure-I duly filled, signed & stamped to be submitted on bidder's letter head.
 - 3. Technical Specification (as per GeM Category Specification) allowed as per system are men tioned in GeM bid, however, in case of any difference, specification as per Annexure-A shall h ave precedence over specification mentioned in GeM bid.
 - 4.Bidder other than OEM needs to submit bid specific OEM authorization/Certificate i.e. OEM a uthorization for GeM bid No. GEM/2023/B/4382536 dated 03.01.2024.

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
